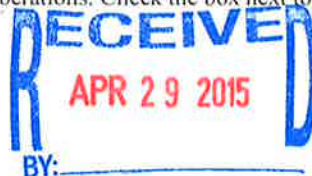

## Psychology Major Program Changes 2-10-15

### Proposed Changes:

1. Remove the GE Designation from PSYC 356: Developmental Psychology: Adulthood and Aging.
2. Add PSYC 356 to the Developmental Core Courses in the Psychology Major

### Rationale for Changes:

1. To align all three of the Developmental Core courses for the Psychology major, we need to remove the GE designation. Thus, all three courses (PSYC 331: Infancy and Childhood: Theories and Research; PSYC 349: Adolescence: Theories and Research; PSYC 356: Developmental Psychology: Adulthood and Aging) will be targeted to a non-GE audience. Whereas PSYC 331 and PSYC 349 are “majors-only” courses for CHAD and PSYC, PSYC 356 will be a non-GE course open to all students who are interested in taking it, including HD majors. This move also helps our college by reducing the number of GE courses offered by Psychology and allows other disciplines to gain FTES.
2. PSYC 356 should be included in the Developmental Core for the Psychology major. It was mistakenly removed last year. The course will serve as one choice in that core, but it will not serve as a prerequisite for PSYC 395.

**From the Catalog:**

*Special Conditions for the Bachelor of Arts and Minor in Psychology:*

All courses counted toward the major, including Preparation for the Major courses, and the minor must be completed with a grade of C (2.0) or better. No more than a total of three (3) units of either PSYC 498 or PSYC 499 may be applied toward the major. No more than three (3) units of PSYC 495 may be applied toward the major. PSYC 356 may satisfy the Developmental Core, but it does not serve as a prerequisite for the PSYC 395 laboratory course. A minimum of eighteen (18) units counted toward the psychology major must have been completed at Cal State San Marcos. For the minor, nine (9) units must have been completed at Cal State San Marcos. Courses taken at other universities for which we do not have articulation agreements will not be counted toward the major at Cal State San Marcos without the written permission of any member of the Psychology faculty listed above.

Hi Alice,

I hope this email finds you doing well! As we have launched the CHAD major, we now have to do some "cleaning up" of items that came to our attention right away. I have attached the following for your review:

1. P2 form for a change in the Psychology major
  - a. We are removing the GE designation from Psyc 356: Developmental Psychology: Adulthood and Aging.
  - b. We are adding Psyc 356 into the Developmental Core for Psychology majors (it was taken out by mistake). It will not serve as a prereq for the Psyc 395 lab (which HD students can't take to satisfy the minor).

The impact on your students: none. They can still take Psyc 356 but it won't count for GE (it didn't for your majors anyway). The prereq will be Psyc 100 (which your students take anyway).

2. C2 form for Psyc 356
  - a. This has the changes described in 1b.
