Our proposed change is to change the requirement of community health clinical course in the RN-BSN program with a different course with a slightly reduced number of units from that is currently being required. The course change would be a substitution of NURS 445 Field Study: Community Health Nursing and Nurse Case Management of three (3) units with a redesigned NURS 447 of two (2) units. Both courses have identical course names, descriptions, and unit values and have been previously used in the BSN program to meet the undergraduate requirement of a clinical course for community nursing. Currently, only NURS 445 Field Study: Community Health Nursing and Nurse Case Management of 3 units is in use for all of the BSN students.

This proposed change came about after review of the evaluations of the online RN-to-BSN program. This proposed change reflects the different needs of the online and currently licensed RNs from the pre-licensure BSN students who are in the face-to-face program at CSUSM. Students in the RN-BSN program are generally experienced working registered nurses who need specific clinical experiences to meet California Board of Registered Nursing (CA BRN) requirements for the Public Health Nursing (PHN) Certificate once they graduate with a BSN. The CA BRN requires 90 hours of specific clinical work in a BSN program to meet the requirements for the PHN certificate. Ninety clinical hours equals two clinical units. The clinical work and hours required for the PHN certificate are included in the current course but are supplemented with additional case management experiences and hours that are essential for the pre-licensure student.

As NURS 447 is a course number associated with community health and still available but not currently being used, we propose to use this course number for the redesigned clinical course for the RN-to-BSN students. A C-2 form and a new syllabus for NURS 447 is currently being reviewed to reflect the new course name, course description, and unit value decrease in the College Curriculum Committee. If approved, the substitution of this course will reduce the Major Requirement of units in the RN-to-BSN Program Option from 64 to 63 units. This change will not affect the minimum number of 120 units necessary for the BSN degree as students are required to complete an additional 51 General Education and 44 Preparation for the Major units.

The revised course with new title, course description and unit value to be substituted is:

NURS 447 Public Health Nursing Practicum (2 units)

Provides clinical experience for registered nurses (RNs) working with diverse populations targeting public health problems. Students work with community partners and health agencies to assess populations, develop programs, provide health education, and assist high-risk or vulnerable populations within the community attain and maintain their optimum level of health. Clinical practicum is community-based and population-focused public health nursing practice that meets the requirements for CA BRN PHN certificate and Quad Council competencies for public health nursing.

Thank you for your consideration of our request as we believe that this change will assist our RN-to-BSN in successfully completing the program.

Accelerated BSN Option

Since students seeking this option are second degree students, many if not all general education units may have already been completed. Students must complete all graduation requirements (p. 105) to receive a second degree. Students must also meet all preparation for the nursing major courses or their equivalent (44 units). The minimum number of units required for the RN-to-BSN option is 120 semester units. A maximum of 70 units can be transferred from the previous nursing program and includes general education, preparation for major courses, and 35 units of lower-division nursing. The number of units needed to be completed may vary depending on units previously completed in a community college. RN-to-BSN students must complete 9 units of upper-division electives and complete the second language requirement. Irrespective of the number of courses previously attempted, RN-to-BSN students will need to complete the following courses or their equivalent(s):
