P-2 Form: Request to make changes to the required elements of the Global Studies major

Request submitted by Elizabeth Matthews, Chair, Global Studies

We are making a series of changes to the Global studies major to better meet the learning outcomes for our students. These changes will help address PSLOs 1-4:

- 1) Describe and explain how their own culture is one of many diverse cultures and that alternate perceptions and behaviors may be based in cultural differences.
- 2) Analyze world geography, global issues, processes, trends and systems.
- 3) Compare and contrast global cultures beliefs, values, religions, arts, practices, and philosophies.
- 4) Interpret and analyze global issues from a variety of disciplinary perspectives to think critically and solve problems.

The learning outcomes are better met with the addition of two new Global Studies courses: GBST 301 (Constructing Global Identity) and GBST 302 (Global Money and Power), both of which will be added to the core and required for all GBST majors. As a distributed major, GBST does not control the content of most courses in our program. Increasing this control through the creation and offering of additional core courses of our own will ensure that students are exposed to the issues and methods the faculty in the Global Studies Department deem most important. To add these courses, and maintain the same number of required units, we will remove two courses currently in the major: ECON 202 and one of the geographic area upper division electives. We believe adding these required core courses better prepares our students for their upper division electives, brings increased coherence to the major (an important point discussed in our recent Program Review), and ensures that they are exposed to methods in both the Social Sciences and the Humanities. As such we request the following changes:

- Add GBST 301 (Constructing Global Identity) to the Upper Division Requirements: GBST 300 is the core course in Social Sciences and GBST 301 will be the core course in the Humanities. This course is critical to the integrity of our program as an interdisciplinary degree.
- Add GBST 302 (Global Money and Power; cross-listed with PSCI 460) to the Upper Division Requirements: Global Studies students must have exposure to the global economic system and ECON 202 has been meeting that need since the program's inception. We appreciate the Economics Department allowing us to use this course, but we are now ready to offer a class focused on the global political economy that meets our needs more closely than Principles of Macroeconomics.
- Delete ECON 202 from Preparation for the Major: GBST 302 will provide students with the most appropriate exposure to global political economy, thus we no longer need to include ECON 202.
- Decrease the classes/units in the Upper Division Electives: Geographic Area: Removing one class or 2-3 units from this area keeps the symmetry of the major. Students are usually exposed to the geographic area of their choice in additional classes, making this the optimal place to reduce units.

Career Opportunities

The Global Studies Degree will be useful to students pursuing careers in international development, international organizations (e.g., United Nations), law, non-governmental organizations focusing on international affairs (e.g., Amnesty International), government, graduate study in History, Political Science, and International Affairs, and education.

Preparation

Prior to taking any upper-division coursework for the major, students are encouraged to complete, or be in the final semester of completing, all lower-division General Education requirements.

Special Conditions for the Bachelor of Arts in Global Studies

All courses counted toward the major, including "Preparation for the Major" courses, must be completed with a grade of C (2.0) or better. A minimum of eighteen (18) units counted toward the major must be earned in residence at Cal State San Marcos. No more than six (6) units of internship, GBST 495, and/or independent study, GBST 498, credit may be counted toward the major. In order to graduate, all Global Studies majors must successfully complete **GBST 400** Senior Seminar during their senior year.

All Global Studies majors must meet a second-language competency requirement. This requirement can be met by completing an approved fourth semester language course with a grade of "C" or higher or by successfully passing a fourth-semester level language competency exam given by the CSUSM Language Learning Center. If the CSUSM Language Learning Center does not offer a competency exam in a student's second language, this student may request that the competency exam be conducted by the Berlitz Language Center. Students requesting this option must receive official approval from the Global Studies Department Chair before scheduling a Berlitz exam. International students may satisfy this requirement by meeting the university's TOEFL requirement for admission.
