Hi Michael and Jessica,

I am writing on behalf of UCC with regards to our review of the P form for a new undergraduate major in Philosophy. UCC would like to thank you for submitting an exceptional P-form that was pleasure to review.

During our review UCC did notice these two minor details:

- 1. On page 12 of the P-form, under question 4b ("Plans for assessing program goals") the narrative indicates "Table II for New Programs". UCC was unable to locate this table.
- 2. On page 28 of the P-form under question 7a the narrative indicates the tenure track search with an anticipated hire of 2015. We assume that this hire is complete? The form may contains other instances of a reference to hire in 2015.

The committee does not consider these to be significant concerns, but for completeness would like it if you could clarify these two points. UCC will be reviewing the C-forms accompanying this proposal next week.
