### **New Business**

- Avoiding controversial venues
  - Should the RA stay away from controversial events? Where is the boundary line? Lori Brockett read Article II – Purpose from the Bylaws which states, "The purpose of the Association is to create a strong organization of CSUSM retirees, to encourage a relationship of mutual support between the University and its retirees, and to promote the University and its programs. To accomplish these purposes, the Association will engage in social gatherings; educational and service opportunities; and practical support and advocacy for CSUSM and its retirees." After a lengthy discussion, it was agreed that the RA should remain neutral and noncontroversial.
- Fundraising for other organizations/causes
  - Should the RA promote events and fundraising for other organizations and causes? After discussing the subject, the board voted not to promote fundraising for other organizations and causes. Vivienne so moved, Bill seconded, and the Board voted in favor of the decision.
  - After discussion, the Board felt it appropriate to let RA members know of events they might be interested in that are not sponsored by the RA Association. On one occasion, Tukwut Times posted a section entitled "Something Extra."
- Upcoming CalPERS Board Election To endorse candidates or not

 There is an upcoming CalPERS Board Election that will start August 30 and ends September 30. There are 13 members on the CalPERS Board, of which six are elected. There is one representative who is elected by retired members; no one else can vote in the election. There will be two candidates on the ballot vying for this position. There was discussion by the Board whether the RA should endorse or not endorse candidates. The Board agreed they should not endorse candidates.
