- Upcoming CalPERS Board Election To endorse candidates or not
  - There is an upcoming CalPERS Board Election that will start August 30 and ends September 30. There are 13 members on the CalPERS Board, of which six are elected. There is one representative who is elected by retired members; no one else can vote in the election. There will be two candidates on the ballot vying for this position. There was discussion by the Board whether the RA should endorse or not endorse candidates. The Board agreed they should not endorse candidates.
