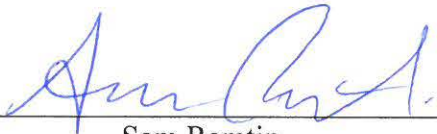

06 Information	Open Forum Guest Chris Lee discussed concerns regarding a "redo" of the previous elections cycle. He mentioned that the students already voiced what they wanted and a revote is not necessary. He wants the previous results shared and approved. He also mentioned concerns regarding an Elections Committee member (Collin Bogie) endorsing certain candidates in the elections cycle. He believed this made for bias committee decisions. He referenced a Facebook event as evidence. He also questioned the committee's decision to remove him from the election process for mass emailing. He called into question what is considered excessive emailing. He mentioned his slate's efforts of in person visits with group presentations and student org outreach had an impacted without the emails. Guest Yomira Zamora discussed and questioned ASI's value of integrity in this elections process. She discussed the need for increased transparency with meetings, complaints, and appeals. She also voiced concerns about the EVP's role of appointing members on committees. She believes this lends itself to bias committee decisions, based on membership of the committee. She believed that Aaron placing Collin on the committee is bias because of their fraternity affiliations.	Sam Ramtin Elections Chair

He discussed the social media support by Collin for one slate over the other. He further discussed the need for the most fair and sound result of elections, which would be to approve the results as they are.</p>	
<p>07 Action</p>	<p>Approval of timeline and process for ASI elections polling</p> <p>Description: The committee chose to rerun vote process for currently qualified candidates. Committee will determine campaign timeline and opening of polls timeline.</p> <p>Fiscal Impact: None</p> <p>Ashley reviewed with the committee the tentative timeline they had requested the staff create.</p> <p>Ahmbra questioned time needing to be included for new videos.</p> <p>Committee discussed and decided to allow candidates use old videos or film new ones, as well as allow the same for their campaign statements.</p> <p>Chris questioned if the video would need to push the timeline back. Ashley confirmed it would</p> <p>Collin discussed the need to share this information on social media and through other means of communication. Kim Clark will connect with the Office of Communications. Ahmbra mentioned she could share the information through the ASI list serve.</p> <p>Chris mentioned the need to share this information with the campus community at large. The committee discussed the possibility of President Haynes needing to share the information with the campus community. The communication should include context and direction to staff, no matter where the information comes from. Katy Rees mentioned the need to buy a little time to share a solid communication message.</p> <p>Sam echoed the need to increase transparency in this effort.</p> <p>Chris also brought up a concern regarding campaign finances. He mentioned that these candidates have already had to cover campaign expenses for the first campaign. Collin agreed that ASI should reimburse for second round. The committee decided that ASI should cover the costs up to \$500 per candidate.
