7 Information	Housing & Dining Update Description: Updates on Housing & Dining, as well as strategy and involvement. Fiscal Impact: None Presenter reviewed dining at CSUSM including the opening of the housing in North City. The project is currently being called The Cube and campus is currently working through what the relationship will be like with that developer and CSUSM Residential Education. The project is slated to open Fall 2022 and will be a traditional housing unit with no kitchens in the rooms. Committee members had questions about plans for The Cube without dining options as well as what happens with current CSUSM on campus housing and food meal plans. Plan is to not have existing housing included in the mandatory meal plans. Presenter also overviewed new housing opportunity for CSUSM from a bill that fund affordable housing options for campuses in the CSU, UC, and CC. The application was due by October 1 and CSUSM submitted for \$150 million for 600 bed housing and dining hall, separate from The Cube project. This housing projected opening would be in 22/23. This housing would be first made available to low income/PELL eligible students. Committee had questions about location for this project as well as mandatory minimums expectations for other housing on campus. Presenter mentioned making a committee that would have 4 student seats on it as well as continued conversation at CSUSM Corp meetings that Julia and Dylan sit on.
