The collective actions and efforts that create: a vibrant economy (fiscal responsibility), socially just communities, and environmentally sound practices that ultimately meet the needs of current and future generations

New Zero Waste + Sustainability Specialist


- Stephanie Hebert retired

Single-Use Plastics Policy

CSU Wide policy – 4 main areas

- Plastic Straws
- Plastic Bags
- Styrofoam
- Single Use Plastic Water Bottles

Policy began Jan 2019 and final phase began Jan 2022

8 Plastic Statistics

The second

13 Million tons of plastic leak into the oceans annually

500 Billion plastic bags used annually worldwide

50 Percent of consumer plastics are single use

1 Million plastic water bottles are purchased every minute

1 oo Years how long it takes for plastics to degrade

17 Million barrels of oil are used annually in plastic production

Composting has started!!!!

SB 1383 – Requires us to divert our food waste and also develop food recovery programs (Jan 1, 2021)

We have 2 Composting efforts going on at CSUSM

- Compost Group (Starbucks, Coffee Cart and Dome)
- EDCO (all other locations, including USU)



What goes in the bin?

Food Scraps

Fruit, vegetables, meat, bones, dairy, eggshells, prepared food



Food-Soiled Paper

Napkins, tea bags, paper plates, coffee filters

Zero Waste Event Planning

Work with ECS- they are well aware of the new changes and we are determining the best next steps

Use all items you currently have - if you purchased water or other items, use them up- as it's more wasteful to just throw them away

Our Vendors know our policies- but doesn't hurt to remind them

We are looking at items that are compostable first, then recyclable then landfilled (For ex. Paper is better than plastic)
