




CSUSM Total FY 23/24 Projected Funding sources - \$307.5

(in Millions)




CSUSM FY23/24 Operating Base Funding Sources - \$215.3

(in Millions)




CSUSM Enrollment




■ Fall - Spring Headcount (Avg)

Long-term sustainability as an organization

- Includes strategic planning
- Keep our eyes on the horizon

People – faculty, staff and students, including graduation success

FY23/24 Budget Highlights

Governor's compact funded for 2023-2024 despite state budget challenges

• Base funding increase at the CSU system-level = \$227.3 million

CO holding funding centrally for systemwide provisions \$132.2 million

CSUSM one of only 11 campuses to receive additional enrollment funding

• 175 additional funded FTES for \$1.5 million

CSU able to fund portion of mandatory cost increases






