- College RTP addendum related to COVID
 - The committee discussed Addendum H that was emailed out "Addressing
 inequities in the RTP process exacerbated by the COVID-19 pandemic". What
 will happen if departments do not want to lower the standards even if university
 RTP standards do, the University document would supersede the department
 document.
- The committee agreed to add a short addendum to the RTP document 1, ask candidates for review to label what items are pandemic related items, 2, describe for them what their disruption was and what proportion of their time was affected.
