

Do You Remember? ~ The Roots of the ACE Scholars Program

Around 2004, Jonathan Poullard, then Dean of Students, informed the Student Affairs leadership team that the CSU had a requirement for services for youth who had aged out of the foster system. Thus began our development of a vision for establishing a strong program of support services for former foster youth here at our campus.

As the Associate Vice President of Student Academic Support Services (SASS), my staff and I began to research current academic services for foster youth in our area, establish links to foster youth programs in the county, and to explore local and campus funding for the establishment of services in Student Affairs.


One of the links we made was an on-site visit to San Pasqual Academy to meet with staff and students. The Academy is located in Escondido, not far from the San Diego Zoo Safari Park and is a first-in-the-nation residential campus specifically designed for foster teens. The students are “provided a stable place to live, individualized educations, and a safe place to learn the skills needed for independent living.” (www.sanpasqualacademy.org)

CSUSM sent a delegation to the academy that day, including President Haynes; Dr. Pat Benson, Vice President of Students Affairs; Dr. Lorena Meza (CLASS); and other representatives of the university. We were able to take a tour of the facilities and talk with both academy staff and students. It was both an inspiring and informational visit that day.

Dr. Lorena Meza and her staff from CLASS were charged with moving forward with the vision of establishing services on campus for this student population. I remember our first one-day conference for current foster youth who were brought to campus to learn that if they worked hard to qualify academically for CSU admittance that we would assist them with admission procedures, securing financial aid and on-campus housing and other services to help them eventually become college graduates. I am sure that for many of them, this was a message that gave them a new vision for their lives. It was an exciting day for both our campus staff and those potential college students.

In 2007, the program was officially established and Jim Mickelson, MSW, was selected as the Director. Over the years, the ACE Scholars Program has become a comprehensive program which is transforming lives of former foster youth. According to their website (<https://www.csusm.edu/ace/>), it services more former foster youth per capita than any other campus in the nation and has achieved an extraordinary 86% persistence rate. That is something of which to be very proud! Recently, it was announced that the program is expanding into Orange County with a partnership with the Orangewood Foundation.

The program is dependent upon the donations of individual donors (79% of operating revenues), so spread the wonderful news about the ACE Scholars Program and encourage possible donors to consider helping our former foster youth through this successful and important program.

MEMBER PROFILE – John R. Montanari

I was born in Greenville, South Carolina on March 11, 1944. (Yes, I am that old!) My family and I returned to my parent's home in Ohio by train when I was 4 weeks old – the youngest baby ever to have traveled on the Southern Railroad at that time. My father was discharged from the Army where he had been stationed in South Carolina. I lived in Cincinnati, Ohio and then Northern Kentucky. After high school, I attended the University of Dayton in Dayton, Ohio where I received my BS in Mechanical Engineering. Never a particularly good engineer, I worked in the Chicago area as a technical sales engineer. In May of 1967 Uncle Sam decided he needed me for the Vietnam War. I enlisted in the Air Force as a Mechanical Engineer and was assigned to a R&D base in Albuquerque, New Mexico. After serving my country and avoiding Vietnam, I returned to school to pursue an MBA. Like most of us, I was mentored by a wonderful faculty member and decided to try for my doctorate. I attended the University of Colorado Boulder receiving my doctorate in management with an emphasis in strategic management in 1976.

My academic career started at the University of Houston – main campus. I was fortunate to work with some of the up-and-coming scholars in management at U of H. After three years, although I enjoyed learning from my senior colleagues, I grew tired of Houston (the city) and accepted a position at Arizona State University. Again, I was fortunate to work with some very talented people. Due to a growing culture of scholarship (publish or perish), I was quite productive during my 11 years at ASU. After making full professor, I decided that I wanted to experience a different aspect of academia – helping to build a new program. A friend in San Diego read about the new CSU in San Marcos and sent me a clipping. I wrote to President Stacy and shortly heard from Bernie Hinton.

As they say, the rest is history.

Report of meeting [of CSU-ERFSA President] with Chancellor's Office Human Resources administrators.

On November 2, 2018 President Bill Blischke, accompanied by Executive Director Harold Goldwhite, met with Chancellor's Office Human Resources administrators Vice Chancellor Evelyn Nazario and her Chief of Staff Joan Torne at the new, enlarged Chancellor's Office at Catalina Landing, Long Beach. The purpose of the meeting was to re-introduce CSU-ERFSA to the new Vice Chancellor after the recent decision to open up membership to retired staff; and to increase the visibility of CSU-ERFSA in the CSU.

In an extremely cordial one-hour meeting President Blischke shared information about the nature and structure of the Association, and the many ways (21 so-far documented) in which CSU retirees assist the University. In turn Vice Chancellor Nazario stressed her interest in working with CSU-ERFSA to get useful information out to retirees. She agreed to give CSU-ERFSA information about upcoming CalPERS campus presentations well before they take place, so that this information could be published in The Reporter. There is a CSU table at some meetings of CalPERS and CSU-ERFSA information could be displayed there. She also suggested that CSU-ERFSA representatives meet with the Community Engagement administrators at the Chancellor's office. She will also ask whether there could be a CSU-ERFSA presentation at an upcoming meeting of campus Provosts.
