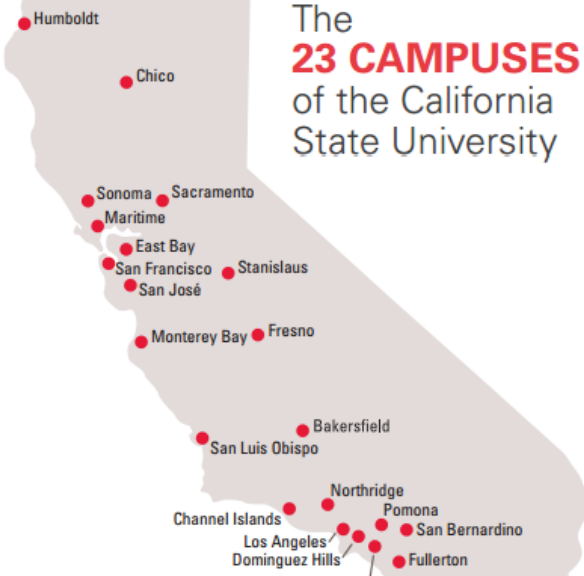

TUITION FEE WAIVER & REDUCTION PROGRAM



The Employee Fee Waiver Program allows eligible employees to attend California State University (CSU) courses at reduced rates. The program is designed to assist employees in improving current job skills or prepare for a new career. Courses are taken for credit, and the program does not apply to Open University, Professional Development Center, or Special Session courses through Extended Learning.

In addition to employee fee waiver, eligible CSU employees may transfer his or her fee waiver benefit to a spouse, domestic partner or dependent child.



EMPLOYEE CATEGORY/ELIGIBILITY



- **Unit 1: Physicians (All Unit Members)**
- **Units 2, 5, 7, & 9: CSUEU**
- **Unit 4: Academic Professionals**
- **Unit 6: Skilled Trades**

Full-Time employees (permanent, temporary & probationary) and Part-Time employees

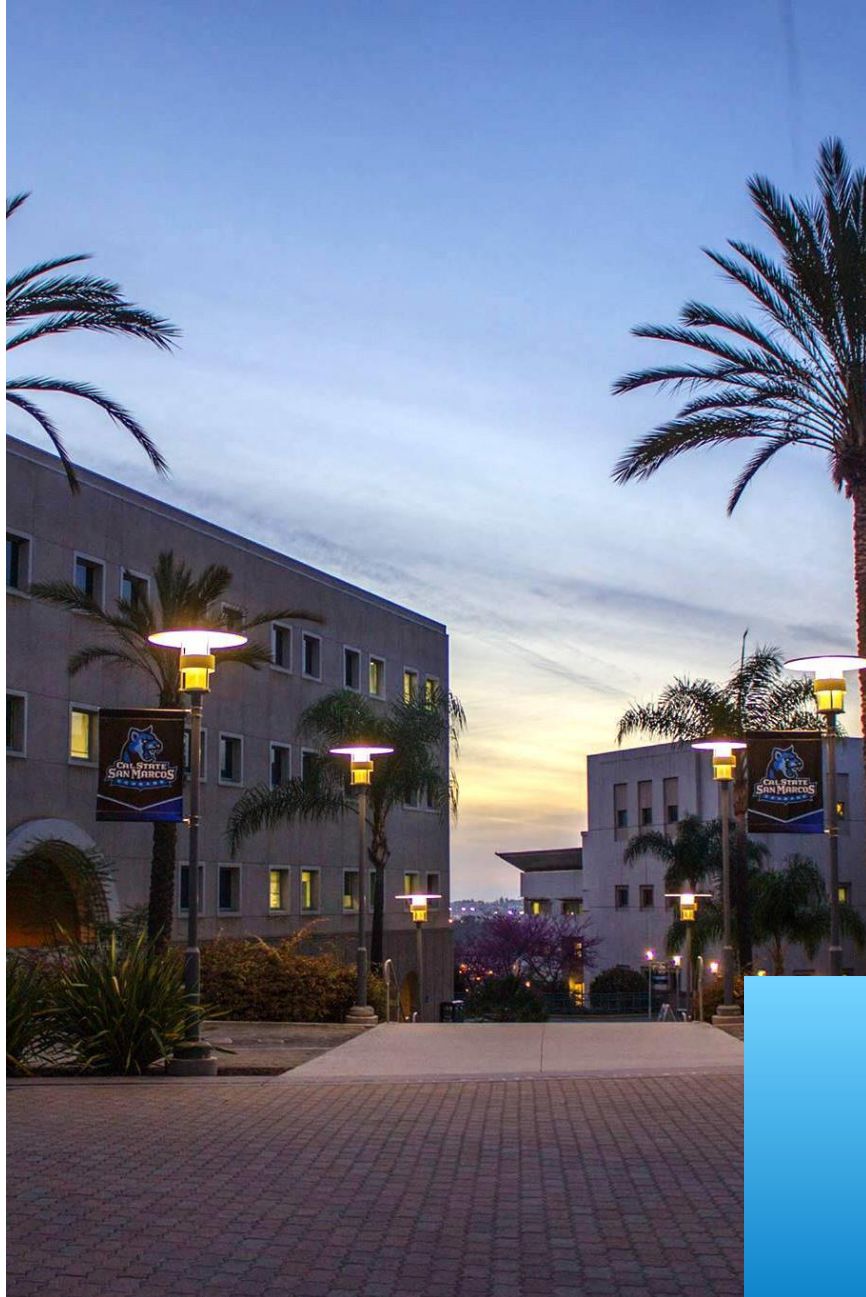


EMPLOYEE CATEGORY/ELIGIBILITY



- **Unit 8: Public Safety**
- **C99: Confidential**
- **E99: Excluded**
- **M98: Executive**

Full-time or part-time permanent employees and full-time probationary employees (no Temporary)



EMPLOYEE CATEGORY/ELIGIBILITY



Unit 3 Faculty

Tenured and probationary faculty unit employees, and temporary faculty with (3) year appointments.

Coaches must have at least 6 years of full-time equivalent service in the department

FERP eligible during semesters/quarters when they are actively employed



EMPLOYEE CATEGORY/ELIGIBILITY



M80: Management Personnel Plan (MPP)

Full-time and full-time temporary employees

Part-time MPP employees are **not** eligible



DEPENDENT FEE WAIVER



- Spouse
 - Dependent Child
 - Domestic Partner
-
- Must be matriculated towards a degree or attainment of a teaching credential in the CSU
 - Courses must be for credit towards completion of that degree or teaching credential
 - Must meet established in-state residency requirements or pay non-resident tuition charges



DEPENDENT FEE WAIVER



*DEPENDENT CHILD is defined in same manner used for CSU benefit programs

- DOMESTIC PARTNER
- If both parents are eligible employees, each may transfer fee waiver benefit to a dependent child/different child
- May enroll at any CSU campus
- Dependent child age limit is age **23** and has never been married
- Dependent child age limit is **25** and has never been married
- Eligibility is the same for health benefits (**must be registered with the State of California**)

EMPLOYEE FEE WAIVER COURSES



- WORK RELATED
 - To improve skills
- CAREER DEVELOPMENT PLAN
 - Must submit application to the university and be officially admitted



EMPLOYEE FEE WAIVER COURSES



A maximum of two (2) courses or six units, whichever is greater, per semester/term

Only state-funded courses may be taken under the fee waiver program

Self-support programs are not eligible for fee waiver (**Extended Learning courses are self-supporting**)



EMPLOYEE FEE WAIVER COURSES



- Normal academic standards must be maintained in order to continue in the fee waiver program
- May use at any CSU campus
- Release time may be taken for one (1) on-campus fee waiver course, if class is during normal work hours – please refer to your appropriate bargaining unit contract
- Courses taken in addition to fee waiver courses, the employee must pay the difference in fees at a regular rate.

TAX FREE OR TAXABLE BENEFITS

- Fees waived may be considered imputed taxable income based on eligible participant and course level.

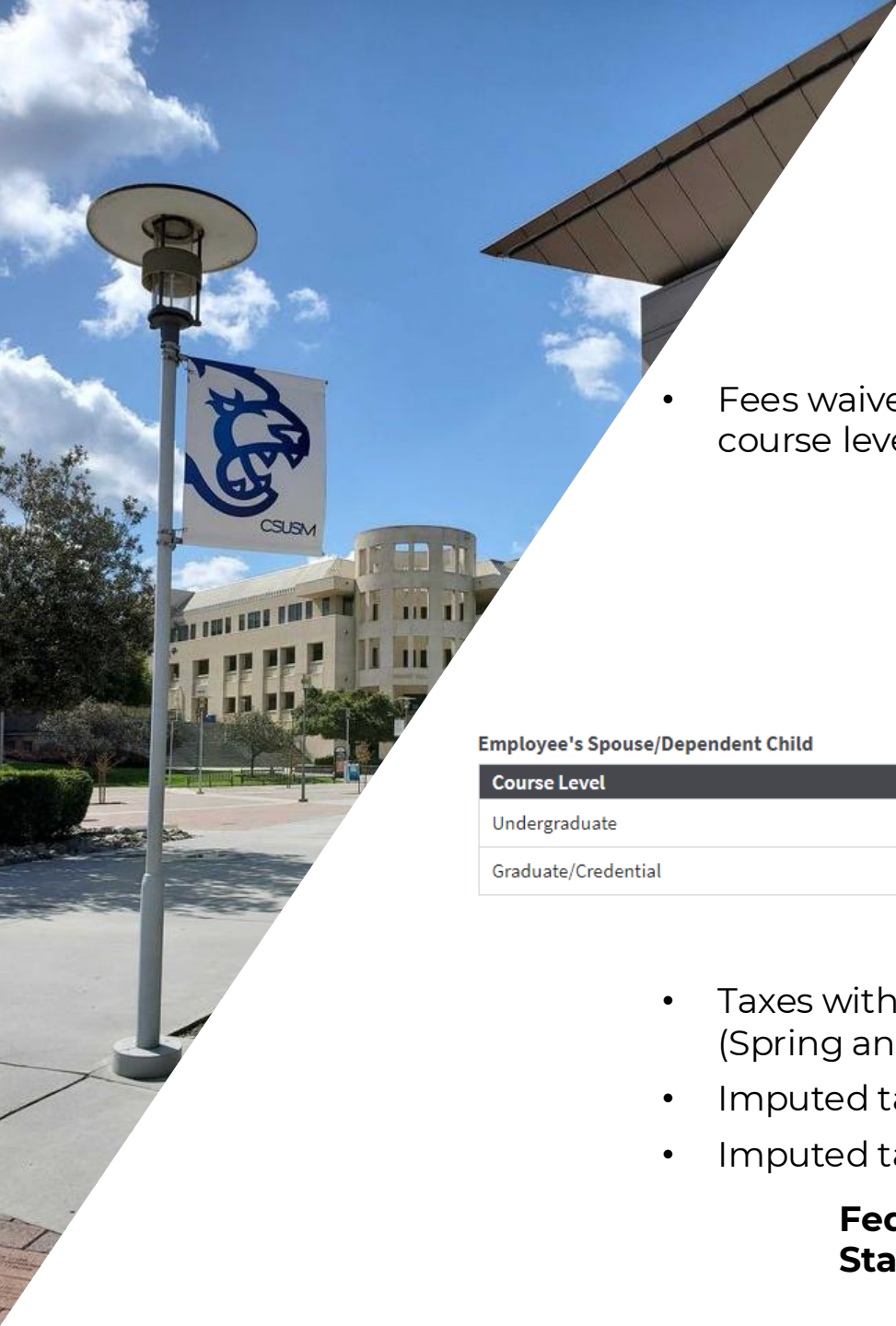

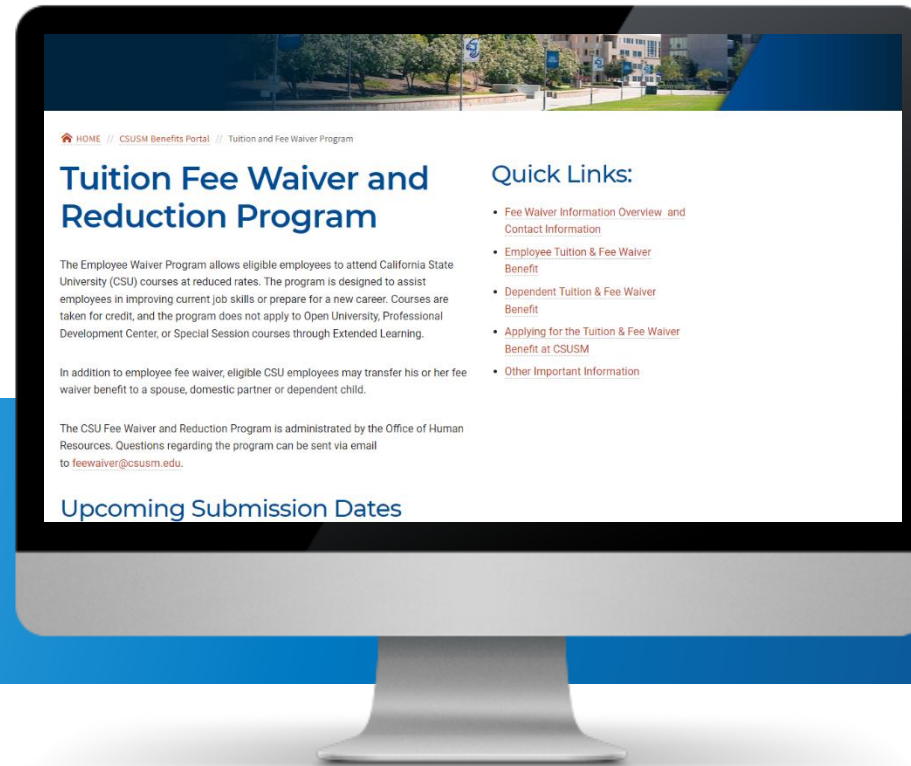
Course Level	Tax Status

Graduate/Credential	Taxable

- Taxes withheld from the employee's paycheck in the month the imputed income is reported (Spring and Fall).
- Imputed taxable income will be included on the employee's W-2 form.
- Imputed taxable income is subject to the following:

Federal = 22%
State = 6.6%

Social Security = 6.2%
Medicare = 1.45%
