 - b. Complainant was given resources for Sexual Violence Advocate and Educator, Student Health and Counseling Services, and Title IX rights and options to report.
- 4. No Investigation, Sexual Misconduct Report
 - a. Complainant was offered support resources; however, did not want to purse nor participate in a campus investigation; therefore, a campus investigation could not be conducted.
 - b. Complainant filed a report with University Police, and vocalized not wanting to move forward with a criminal investigation.

 - a. Complainant unable to identify Respondent or if the respondent is a student.
 - b. Complainant given resources and support information.
 - c. Complainant stopped responding to campus communication attempts.

 - a. Respondent is a non-student. Incident occurred off-campus.
 - b. Complainant given resources on-campus, but student declined due comfortable use of off-campus resources.

- c. Complainant received on-campus and Title IX resources, as well as ongoing support with Sexual Violence Advocate and Educator, and additional remedies pertaining to classes.

 - b. Incident occurred prior to complainant becoming a student at CSUSM
 - c. Complainant received support for withdrawal petition

 - a. Respondent is non-student.
 - b. Incident occurred prior to complainant becoming a student at CSUSM.
 - c. Complainant given on-campus resources and support for retroactive withdrawal petition.
- 5. No Investigation, Third Party Sexual Misconduct Report
 - a. Respondent is non-student. Incident occurred off-campus
 - b. Complainant worked closely with CARE Manager, where resources and support for withdrawal petition and SAP appeal was provided.
- 6. No Investigation, Third Party Stalking and Dating Violence Report
 - a. Respondent is non-student.
 - b. Complainant filed a report with University Police, and continues to work with CARE Manager and Sexual Violence Advocate and Educator for support.
- 7. No Investigation, Third Party Dating Violence Report
 - a. Respondent is non-student.
 - b. Complainant did not want to file a report with the police, and received university resources for support.
- 8. No Investigation, Third Party Sexual Misconduct Report
 - a. Complainant reported incidents that occurred prior to attending CSUSM, in class assignment.
 - b. Respondents were non-students.
 - c. Complainant received support from on-campus, and faculty. On-campus resources were provided as well.
- 9. No Investigation, Third Party Sexual Misconduct Report
 - a. Respondent is non-student.
 - b. Complainant filed report with University Police and a detective was assigned to case.
 - c. Complainant received resources for Sexual Violence Advocate and Educator, Rights and Options, and withdrawal support letter.
- 10. No Investigation, Third Party Domestic Violence Report

- a. Respondent is non-student. Complainant obtained restraining order.
- b. Complainant received support for a retroactive withdrawal petition from a course.
- 11. No Investigation, Third Party Sexual Misconduct Report
 - a. Complainant reported rape that occurred in Northern California by a nonstudent party.
 - b. Complainant filed report with a Northern California police department. University Police was also made aware of the situation.
 - c. Complainant received resources for Sexual Assault Advocate, Student Health and Counseling Services, University Police and support regarding courses.
- 12. No Investigation, Third Party Sexual Misconduct Report
 - a. Respondent was a non-student.
 - b. Student received on-campus support resources and worked with Sexual Violence Advocate and Educator and CARE Manager for additional support.

 - b. Complainant offered on-campus support with Sexual Violence Advocate and Educator, as we as support for in terminating housing lease.
