APA

Citing sources requires two forms of citation:

- (1) a brief **in-text citation** next to any material you have summarized, paraphrased, or quoted
- (2) a corresponding citation with more detail within a list of all your sources on a **References** page.

IN-TEXT CITATIONS

An in-text citation appears at the end of the sentences; include author, year, & pages (for direct quotations).

In-Text Citation When Paraphrasing

- One researcher found students do better on research papers when they work with a librarian (Li, 2016).
- In her research, Li (2016) found students do better on research papers when they work with a librarian.

In-Text Citation When Quoting

- According to Li (2016), "consulting a librarian greatly benefits students writing research papers" (p. 103).
- One author states, "consulting a librarian greatly benefits students writing research papers" (Li, 2016, p. 103).

In-Text Citation for Sources with No Author

Give first few words of title in quotation marks and year:

- People who love writing read with a pen in their hand to... ("How Writers Read: A Reflection", 2015).

In-Text Citation for Sources with 6+ authors

List et al. after first author: (Arias et al., 2017).

- Arias et al. (2017) argues that help-seeking behavior is an indicator of long term success.

A References page is the final page of a research paper and should be **alphabetized** and **double-spaced**. All citations longer than one line should have a .5 inch hanging indent:

A digital object identifier (DOI) is a unique series of numbers and letters assigned to some journal articles. A DOI is often listed on the first page of an article (or sometimes in the header or footer). Include the DOI as a link in the reference using the following format:
